
Rob suggested using a dummy cartridge to demonstrate voting machines if state approved. Voter cards are to be mailed to all voters.

Obion County Election Commission - Minutes of Meeting - September 21, 2004

Meeting was called to order by Rob Joyner, chairman pro tem, at 8 a.m. Members John Algee and Ethelene Bruce White and administrator Ruth Kendall were also present.

Ruth reported on status of vinyl siding for building.

Ethelene White moved that we appoint early voting, nursing home, and election day workers for the November 2, 2004, elections as recommended by Ruth. John Algee seconded. Motion carried.

It was agreed to have the precinct officers come in for an in-depth training session separate from the judges and registrars. Yates Scribner and Ethelene will assist Ruth in the training.

To make it easier for workers to know all rules and procedures, it was recommended that instructions for workers be placed in binders with tabs identifying the different sections, as well as continuing using various colored paper.

In response to requests from the Mayor and City Hall officials in Obion, John Algee made the motion to change the voting location in Obion from the City Hall to the Community Center, in time for the November 2004 election. Ethelene White seconded. Motion carried.

Discussed the survey for the handicapped which must be completed by March 15, 2005. Ruth was instructed to contact the person who has volunteered to conduct the survey at no charge and schedule that to be done.

Ruth was asked to follow-up on the request to First Christian Church to use their facility for elections for District 2 rather than the Fire Station.

Discussed the use of the City Affidavit. It was agreed that when it is necessary to order a new supply, the City Affidavit will be incorporated with the Application Form. This is to eliminate extra paperwork and to reduce the possibility of worker error.

According to the State Election Office, we cannot combine early and absentee votes within their respective precincts. Ruth has notified ES&S of this.

John asked Rob to write down instructions for ES&S computer operation, to be available in case someone else needs to operate that system on election day.

Ruth will have the counting board come in early so they can complete their work and be out of the committee room before 7 p.m.

Discussion regarding the question of whether a candidate for City Judge of Union City must be a resident of the city for a specific period of time. According to the State Election Office, if

incumbent wants to challenge such candidacy he must wait until after the election since the candidate in question has already been certified by the Commission and is on the ballot. Section 6-33-102 is not specific about residency requirements.


The Commission met briefly with Election Office Deputy Krista Staggs who is completing three months of work.





OBION COUNTY ELECTION COMMISSION
Minutes of Meeting - December 6, 2004

Chairman Pete Algee called the meeting to order at 8 a.m. All members were present.

Discussion was held concerning relocating polling places.


The Union City Fire Station precinct needs to be relocated due to inadequate space and parking. Five locations within that district were discussed: Eddie Cox Senior Center, Fellowship Hall of First Christian Church, Fellowship Hall of Exchange Street Church of Christ, West Tennessee Regional Health Department, and Fellowship Hall of Second Baptist Church. Ethelene White is to check into the possible use of the Eddie Cox Senior Center. The Exchange Street church was the second choice, and the church elders have already approved its use if selected.


The Union City Civic Auditorium precinct needs to be relocated due to inadequate space and a very steep handicapped ramp. Four locations within that district were discussed: Community Room of the Obion County Public Library, Community Room of the Obion County Museum, Fellowship Hall of Community Church of Christ, and Fellowship Hall of Immaculate Conception Catholic Church. It was decided that Rob Joyner will check into the possible use of the Library. The Community Church of Christ was the second choice, and the church elders have already approved its use if selected.

The Miles School area was previously voted on to be re-opened, pending finding a suitable location and receiving necessary funding from the County Commission. Pete Algee will check into appropriate locations; suggestions were the community building behind the school or a church in the area such as Pilgrim Rest Baptist Church. The Mason Hall precinct was previously voted on to be re-opened in the former location of the community hall, pending receiving necessary funding from the County Commission. Ruth Kendall is working with C-TAS to determine legal requirements for reopening the Miles and Mason Hall precincts.

We will meet at 8 a.m. on Monday, January 10, to finalize these changes, in order to allow time for the required disability survey to be completed before March 15, 2005. Mr. Merrell has indicated he is willing to assist with this survey, with two days notice.

Dave Frankum moved that the meeting adjourn. Ethelene White seconded the motion. All agreed.
